APPENDIX TWO

New Government Guidance on Biodiversity

Under the Natural Environment and Rural Communities Act 2006 there is a duty on public authorities tin England to have regard to conserving biodiversity as part of their policy or decision making. Conserving biodiversity can include restoring or enhancing a population or habitat.

English public authorities including town and parish councils should be able to show their duty to have regard for conserving biodiversity and how they integrate biodiversity by:-

- Developing policies and strategies and put them into practice
- Manage the planning system
- Manage their:
 - Land and buildings
 - Woodlands and nature reserves
 - o Gardens, parks and public open spaces
 - Community amenities eg sports grounds and cemeteries
 - Waste and pollution
 - Energy and water
 - Wood and plant products
- How they develop infrastructure such as roads, buildings or flood defences
- Make decisions about procurement
- Implement economic, environmental and social programmes

This duty has been reinforcedunder the Environment Act 2021 and government guidance asking for councils to complete their first consideration of what action to take for biodiversity in their locale by 1 January 2024 and agree policies and objectives as soon as possible.
